• Main responsibilities

In the Benedetto Costantino Law Firm, where I am currently a permanent collaborator, I am concerned with lease rights (both commercial and residential), successions, bankruptcy, commercial law, intellectual property, labor law with specific reference to the relationship between commercial agents and principals. Among the most significant experience acquired within the Costantino Law Firm, I particularly emphasize, in the judicial context, my assistance in important disputes in the areas of 1) real estate contracts, 2) contractual failures regarding the implementation of renewal energy plants and experimental prototypes for the so-called augmented reality (for civilian and military usage), 3) IP rights in the pharmaceutical and mechanical sectors, 4) liability management actions, 5) rental agreement laws for residential and industrial cases, 6) unlawful competition of former members and directors, and 7) failure laws.

In court, given the strong international vocation of my Law Firm, I was concerned with the drafting of opinions, in English, in favor of foreign companies aiming at establishing branches in Italy.
